Ottawa, May 24, 2019 – A decision was issued today by Justice Sébastien Grammond of the Federal Court in file T-146-19:

IN THE MATTER OF SAMANTHA WHALEN versus FORT MCMURRAY NO. 448 FIRST NATION

Translation of Summary into Cree and Dené

The Federal Court is committed to being more accessible to Indigenous people when they wish to bring legal disputes for resolution by the Court. For example, many Court hearings are held directly in the Indigenous community or via webcast from a Courthouse; and where appropriate, Court procedure is adapted to make space for Indigenous protocols and legal traditions. With the release of today’s decision, the Court is also taking another step in making Court decisions more accessible – with a summary prepared and recorded in the Indigenous language of the parties. The Court thanks the language keepers who assisted with preparation of this summary in Cree and Dené.

Summary of Judgment

In January 2019, the Council of the Fort McMurray First Nation suspended one of its members, Councillor Samantha Whalen. The Council concluded that Councillor Whalen engaged in wrongful conduct, including the disclosure of financial information and her participation in a blockade of the First Nation’s premises.

Councillor Whalen challenged the Council’s decision before the Federal Court on the grounds that the Council did not have the power to suspend her.

The Court agreed with Councillor Whalen. The Court noted that the Fort McMurray First Nation has an election code, and that the Council defended its decision relying on a provision in the election code that says that councillors can be removed or suspended if they do certain specific things. However, the Court found that Councillor Whalen did not do any of those things. The Council cannot suspend a councillor for reasons other than those mentioned in the election code.

The Council also defended its decision by stating that it was based on the First Nation’s custom. The First Nation said that in the last 25 years, it had suspended three councillors. The Court disagreed with the First Nation. The Court concluded that two of the suspensions were for reasons that were mentioned in the election code. The other suspension was voluntary. Therefore, the First Nation does not have a custom of suspending councillors for reasons other than those mentioned in the election code.

The Court struck down the Council’s decision and reinstated Councillor Whalen.
